**Announcing an alliance between the Japanese subsidiary of Polaris, one of
the world's largest snowmobile companies, and MarketEnterprise**

**The World's First Snowmobile Trade-in Program
at Authorized Dealers**

Polaris Japan Inc. (Head office: Nishi-ku, Yokohama; General Manager: Kintaro Izumida), the subsidiary in Japan of Polaris Inc., one of the world's largest manufacturers of snowmobiles, and MarketEnterprise Co., Ltd. (Head office: Chuo-ku, Tokyo; President & CEO: Yasushi Kobayashi; TSE Mothers: 3135), which primarily operates the second-hand online business, have agreed to establish a business alliance. In November 2019, the two companies will start an official program that allows people purchasing a Polaris snowmobile from an authorized Polaris dealer in Japan to trade in the snowmobile they currently own. Polaris dealers will accept any type of snowmobile of any manufacturer. This is the first official trade-in program offered by a manufacturer in the snowmobile industry that uses authorized dealers.

This trade-in program will better enable Polaris Japan to capture a larger share of the snowmobile market in Japan. MarketEnterprise buys and sells a broad range of second-hand products, everything from home appliances and sporting goods to agricultural equipment, construction machinery and medical equipment. This alliance allows MarketEnterprise to use its expertise at providing a second-hand merchandise purchasing service that offers the same prices anywhere in Japan in order to facilitate a trade-in service for a manufacturer. MarketEnterprise plans to use numerous activities to become a vital partner for manufacturers in order to facilitate their direct-to-consumer services.

Polaris Japan is wholly owned by Polaris Inc., a U.S. company that is the global leader in the powersports sector. In April 2019, Polaris Japan started operations as Japan's only authorized importer and retailer of Polaris products. Initially the company handled Polaris snowmobiles and Timbersled snow bikes. In October 1, Polaris Japan also started importing and selling motorcycles made by Polaris subsidiary Indian Motorcycle, the oldest U.S. motorcycle brand, and off-road vehicles.
