At the meeting of the Board of Directors held today, we have decided to submit a resolution regarding the distribution of surplus as of the record date of April 30, 2026, at the 28th Ordinary General Meeting of Shareholders to be held on July 29, 2026, as follows.

2. Policy on Distributing Profits to Shareholders

Recognizing that returning profits to shareholders is an important management issue, our basic policy is to strive to increase shareholder value by continuously growing our business and improving capital efficiency, while also continuously paying dividends. The amount of dividends is determined by comprehensively taking into account the consolidated business results, soundness of the financial position and the level of internal reserves for future business development.

3. Reason

The dividend payout ratio is set at 20% or more in the year-end dividend. Based on comprehensive consideration of the future development of business, we decided to pay a year-end payout of JPY22.50 per share.
