AIS Co., Ltd. and Medical Force Inc. Signed OEM Agreement "Mighty QUBE® Hybrid"Provided to Cloud-Based EMR"medicalforce" to Strengthen Insurance-Covered Medical Service Functionality

AIS Co., Ltd. (Head Office: Chiyoda-ku, Tokyo; President and CEO: Masayuki Aoki; hereinafter "AIS"), a consolidated subsidiary of our company, has begun providing its "Mighty QUBE® Hybrid" on an OEM basis to the cloud-based electronic medical record (EMR) system "medicalforce," developed and offered by medicalforce Inc. (Head Office: Shinagawa-ku, Tokyo; CEO: Shoichi Hatanaka; hereinafter "medicalforce"), a company that specializes in EMR and appointment management systems for self-pay clinics. The OEM provision commenced on July 29, 2025.



1. Background and Future Outlook

"medicalforce", the cloud-based electronic medical record (EMR) system offered by medicalforce, enables centralized management of clinic operations across a wide range of specialties, including self-pay clinics, plastic surgery, and gynecology. In February 2024, it significantly strengthened its support for insurance-covered services through integration with "Web ORCA", the cloud version of the standard medical billing software provided by the Japan Medical Association. The system has already been adopted by approximately 600 clinics, and further expansion is expected as more self-pay medical institutions begin incorporating insurance-covered services.

"Mighty QUBE® Hybrid", offered by our company, leverages over 30 years of accumulated medical database knowledge and AI technology to generate probable diagnoses in real time based on input data such as prescriptions, injections, and test orders. This helps prevent human errors, including incorrect prescriptions and missed diagnoses, thereby enhancing patient safety while simultaneously improving operational efficiency for healthcare professionals. Through this OEM

agreement, these high-value-added functions are fully bundled into "medicalforce", further enhancing its insurance-related functionality. We believe this collaboration will not only support greater sophistication in insurance service features, but also contribute to physician workstyle reforms, clinic management optimization, and the resolution of broader social challenges.

This OEM model marks the second such partnership, following the 2024 provision of "Mighty QUBE® Hybrid" to "homis", a cloud-based EMR specialized in home healthcare developed by MedicalInformatics Co., Ltd. As a result, the system is expanding its reach across a diverse range of care settings, including home healthcare, self-pay services, and insurance-covered medical care.

Looking ahead, we aim to accelerate the rollout of "Mighty QUBE® Hybrid" within the clinic segment, targeting both existing and new "medicalforce" users. Through this OEM initiative, we are projecting an average annual revenue growth of 116% in this segment from FY2025 through FY2027.

2. About "Mighty QUBE® Hybrid" – Real-Time Ordering Check Software Integrated with EMR "Mighty QUBE® Hybrid" is a real-time ordering check solution designed to prevent medical errors such as incorrect prescriptions or missing diagnoses during order entry or EMR input. The system cross-checks disease names and drug indications in real time based on a highly reliable database utilized by approximately 20,000 medical institutions in our group's client base. As our most advanced product, "Mighty QUBE® Hybrid" supports both cloud and on-premises deployment, contributing to enhanced medical safety, improved operational efficiency for physicians, and cost reduction in hospitals.

3. About "medicalforce" - All-in-One SaaS for Clinics

"medicalforce" is an all-in-one SaaS platform tailored for clinics, offering a wide range of features that align with clinical workflows, including EMR, appointment scheduling, billing, payments, and inventory management. Its appointment management functions streamline operations by reducing time spent on phone-based scheduling by approximately two-thirds. Additionally, the platform supports integration with LINE and provides optimized scheduling features to help clinics boost their revenue. As of today, "medicalforce" has been implemented in over 600 clinics across Japan, regardless of their size or specialty.
