Announcement of Investment in WAmazing, Inc.

ITFOR Inc. (Headquarters: Chiyoda-ku, Tokyo, President and Representative Director: Koji Sakata) has made an investment in WAmazing, Inc. (Headquarters: Taito-ku, Tokyo, Representative Director: Fumiko Kato, hereinafter referred to as "WAmazing"), a startup company that operates "TFaaS" (Tax-Free as a Service), Japan's first online tax-free shopping platform for inbound tourists. This investment was made through a third-party allotment of new shares, and the transaction was completed on April 1, 2026.

WAmazing operates an inbound tourism platform for international visitors, centered on "Tax-Free E-commerce" and providing a comprehensive range of reservation services for snow resort lift passes, transportation, and various local experiences. WAmazing's "TFaaS" offers an innovative shopping experience where travelers can reserve items online and pick them up tax-free at any time before leaving Japan. Customers can then collect their tax-free purchases from patented tax-free automated vending machines located at major airports and airport stations, as well as at over 160 hotels nationwide. As the market enters a transformative era with the "DX-driven evolution of tax-free shopping" following the November 2026 tax reform, WAmazing stands out as a rare player possessing both a robust digital foundation and critical physical assets at major airports and key locations.

Many of our clients struggle with a common issue: while inbound tourism is thriving, they have yet to successfully convert this demand into regional consumption. Through this investment, we will integrate our extensive network of regional financial institutions—backed by our dominant market share of over 70% in credit screening and delinquent debt management systems—with WAmazing's tax-free shopping platform. This synergy aims to establish a "social infrastructure" that directly channels foreign currency into regional economies, while further advancing our corporate purpose: "Social Contribution through Regional Revitalization."
