■ Monthly Sales Update – BOOKOFF Operations in Japan

Existing store sales in BOOKOFF Operations in Japan increased by 7.1% year on year (total store sales increased by 7.0%). Net sales of trading cards/hobby goods, books, jewelry/watches/brand bags, apparel and home appliances/smart phones exceeded those of the same month last year, contributing to the overall growth in existing store sales.
