Notice Regarding Changes (Planned) in Major and Principal Shareholder

Belluna Co., Ltd. (hereinafter "the Company") hereby announces that changes in its major shareholders are expected to occur as of March 31, 2026, as detailed below.

1. Background of the Change

The Company received a report today from Friend Stage Asset Management Co., Ltd. (hereinafter "FSAM"), the Company's major and principal shareholder, regarding an absorption-type merger in which Friend Stage Co., Ltd. (hereinafter "Friend Stage"), the parent company of FSAM, will be the surviving company and FSAM will be the dissolving company. As a result of this merger, all shares of the Company held by FSAM are scheduled to be succeeded to by Friend Stage as the surviving company, which will result in changes to the Company's major and principal shareholder.
